5.	Treasurer	One	Open to all life/ordinary members Head Quarters (IIOR) only
6.	Councillors	Five	One for each zone open to all life/ordinary members from respective zones.
Norther Zone			Jammu & Kashmir, Himachal Pradesh, Punjab, Haryana and Delhi.
Central Zone			Uttaranchal, Uttar Pradesh, Bihar, Madhya Pradesh, Chattisgarh and Jharkhand.
Easter Zone			Arunachal Pradesh, Assam, Nagaland, Manipur, Mizoram, Tripura, Megalaya, /Sikkim, West Bengal and Orissa.
Western Zone			Rajasthan, Gujarat, Maharashtra and Goa
Southern Zone			Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu, Pondicheery, Andaman & Nicobar and Lakshadweep.

Eligibility and other details:

1. Nominations must reach the returning officer on or before **5.00 PM on 31 March,2022.**
2. All the life members and ordinary members are eligible to hold any office of the society and have voting right also.
3. Honorary members, patrons, student members and corporate members do not possess voting right and are neither eligible for holding any office nor sponsoring any nomination.
